APPROVAL OF MINUTES:

At 4:11 pm, a motion for approval of the July 28, 2020 meeting minutes was called by Jack Crowley. Seconded by Jennifer Zwirn. The board unanimously agreed, it passed without dissent.

FINANCIAL REPORT:

At 4:13 pm, Brittany Baker reviewed the financial reports for The Classic Center, CVB, Theatre and Arena with the board.
